



# CHAIRMAN'S MEMORANDUM

TO: SHERIFFS, CHIEF ADMINISTRATIVE OFFICERS, COMMISSIONERS OF CORRECTION, AND POLICE CHIEFS

RE: HEALTH ADVISORY: PENAL LAW AMENDMENTS AND NYS SYRINGE EXCHANGE, EXPANDED SYRINGE ACCESS AND OPIOID OVERDOSE PREVENTION PROGRAMS

On October 28, 2010, sections 220.45 (Criminally Possessing a Hypodermic Instrument) and 220.03 (Criminal Possession of a Controlled Substance in the Seventh Degree) of the Penal Law were amended to reflect existing Public Health Law with regard to the above referenced New York State public health initiatives.

Section 220.45 of the Penal Law was amended to clarify that persons do not act unlawfully by possessing needles or syringes without a prescription *if* they participate in the State's Syringe Exchange, Expanded Syringe Access and Opioid Overdose Prevention Programs. Syringe Exchange and Expanded Syringe Access have been authorized under Public Health Law section 3381 and Title 10 of the New York Codes, Rules and Regulations. Opioid Overdose Prevention has been authorized under Public Health Law section 3309 and Title 10 of the New York Codes, Rules and Regulations.

Section 220.03 of the Penal Law was amended to clarify that possession of residual amounts of a controlled substance on syringes/needles is not unlawful if individuals are permitted to possess these hypodermic instruments under the aforementioned public health laws.

The Syringe Exchange and Expanded Syringe Access Prevention Programs, which create access to new sterile syringes, were implemented to prevent sharing of syringes to reduce transmission of HIV/AIDS. Participants in these programs are in legal possession of syringes without a prescription. The Opioid Overdose Prevention Program was created to reduce fatalities related to overdoses, 70% of which involve the use of opioids. This public health initiative allows participants to possess syringes and vials of Naloxone/Narcan.

Sheriffs and police departments should be mindful of these programs when considering charges for syringe and residue possession, as well as possession of Naloxone/Narcan.
