GREETINGS:

WHEREAS, the Medical Review Board has reported to the NYS Commission of Correction pursuant to Correction Law, section 47 (1)(d), regarding the death of Kevin DelRosario who died on April 23, 2020, as result of circumstances which occurred while an incarcerated individual in the custody of the New York City Department of Correction, the Commission has determined that the following final report be issued.

FINDINGS:

1. Kevin DelRosario was a 30-year-old male who died on 4/23/20 due to COVID-19 infection while in the custody of the New York City Department of Corrections (NYC DOC) at Bellevue Hospital.
2. On 2/7/20, DelRosario was admitted into the NYC DOC from Queens Supreme Court after a plea of guilty for Promoting a Sexual Performance by a Child. DelRosario was sentenced to a three-year maximum term with three-years post release supervision.
