GREETINGS:

WHEREAS, the Medical Review Board has reported to the NYS Commission of Correction pursuant to Correction Law, section 47 (1)(d), regarding the death of Albert Drye, who died on June 21, 2022, as result of circumstances which occurred while an incarcerated individual in the custody of the New York City Department of Correction, the Commission has determined that the following final report be issued.

FINDINGS:

1. Albert Drye was a 52-year-old male who died on 6/21/22 from complications of Bacterial Endocarditis with Methicillin Resistant Staphylococcus Aureus (MRSA) infection while in the custody of the New York City Department of Correction (NYC DOC) at Bellevue Hospital.
2. Drye was born in Bronx, NY. Drye was unemployed. There was no further demographic or social history pertaining to Drye available to the Commission.
